**THIS MATTER** coming up before Honourable Justice D.S.Majanja for Mention on 9<sup>th</sup> June 2020 and **UPON READING** the consent letter dated 9<sup>th</sup> June 2020 and filed by Counsel for the Applicant

**IT IS HEREBY ORDERED BY CONSENT:**

1. **THAT** in view of the application by KEPSA for leave to conduct virtual and/or hybrid meetings on the basis of the impracticability to hold physical general meetings due to the ongoing novel Coronavirus 2019 (COVID-19) pandemic and the related public health regulations and directives passed by the Government of Kenya precluding inter alia public gatherings
2. **THAT** leave be and is hereby granted to Kenya Private Sector Alliance Limited to hold, convene, and/or otherwise conduct a general meeting employing the use of technology, which technology is to include, but not limited to, the use of virtual, electronic, telephonic and/or any other hybrid means necessary to facilitate the running of the general meeting and all related business thereto, subject to compliance with the provisions of the Companies Act, the regulations and the guidelines issued by the Registrar 'Guidelines on the Conduct of Hybrid and Virtual General Meetings by Companies' published on the Business Registration Service website, [www.brs.go.ke](http://www.brs.go.ke)

3. **THAT** leave be and is hereby granted to Kenya Private Sector Alliance Limited's members who are not listed limited liability companies, who so desire, to hold, convene, and/or otherwise conduct general meetings employing the use of technology, which technology is to include, but not limited to, the use of virtual, electronic, telephonic and/or any other hybrid means necessary to facilitate the running of the general meeting and all related business thereto, subject to compliance with provisions of the Companies Act, the regulations and the guidelines issued by the Registrar 'Guidelines on the conduct of Hybrid and Virtual General Meetings by Companies' published on the Business Registration Service website, [www.brs.go.ke](http://www.brs.go.ke)
4. **THAT** the orders so granted in 2 and 3 above be applicable to any company which it impracticable to conduct its general meeting in the manner required by its Articles of Association and the Companies Act due to the ongoing Covid-19 pandemic restrictions under the Public Health Act and other related public health laws, regulations and directives currently in force and as may be passed from time to time.
5. **THAT** it is hereby ordered that any meeting convened, held and conducted in accordance with this order be taken for all purposes to be a general meeting of the company properly convened, held and conducted.
